ORDINANCE № 2010-004

AN ORDINANCE OF THE CITY OF EAST BERNARD, TEXAS, PROVIDING FOR A COMPREHENSIVE TRAFFIC SAFETY AND CONTROL PLAN INCLUDING DESIGNATION OF STOP AND YIELD INTERSECTIONS, ONE-WAY STREETS, PEDESTRIAN CROSSWALKS, SCHOOL ZONES; PROVIDING A PENALTY OF AN AMOUNT NOT TO EXCEED \$200 FOR EACH VIOLATION OF ANY PROVISION HEREOF; PROVIDING FOR SEVERABILITY; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH.

WHEREAS, it is the Board of Aldermen's intention to provide safe streets within the city for both vehicular traffic and pedestrian traffic by creating a Comprehensive Traffic Safety and Control plan which will establish school zones, pedestrian crosswalks, one-way streets, safe speed limits within the city and also provide intersections with stop signs.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF EAST BERNARD, that the following Comprehensive Traffic Safety and Control Plan shall be adopted by the City of East Bernard.

Comprehensive Traffic Safety and Control Plan

Section 1. Four-way stop intersections designated: (north and south bound / east and west bound streets)

Within the city, the following intersections are designated as four-way stop intersections.

- a) Koym St west at its intersection with East St.
- b) Koym St east at its intersection with East St.
- c) East St south at its intersection with Koym St.
- d) East St north at its intersection with Koym St.
- e) Koym St west at its intersection with Ray St.
- f) Koym St east at its intersection with Ray St.
- g) Ray St south at its intersection with Koym St

Section 4. Yield right-of-way intersections designated

Within the city, the following intersections are designated as yield right-of-way intersections:

a) Hargis St at its intersection with San Bernard Dr

West St north at its intersection with Wallace St

Section 5. One-way only streets designated

Within the city, the following intersections are designated as one-way only streets:

a) The following part of Fitzgerald St is designated as a one-way only street from the hours of 7AM to 9 AM and 2PM to 4PM, Monday through Friday during school days:

Fitzgerald St east-bound from its intersection at Magnolia St to its intersection at Leveridge St.

Section 6. Pedestrian cross-walks designated

Within the city, the following intersections are designated as pedestrian cross-walks:

- A) Designation: The following areas are designated as pedestrian crossings, and crosswalks shall be delineated in these areas:
 - a) Leveridge St at its intersection with Fitzgerald St
 - b) Leveridge St at its intersection with College St
 - c) College St at its intersection with S Urbanec St
 - d) Fitzgerald St at its intersection with S Urbanec St
 - e) Clubside Dr at its intersection with Edgeview Dr
 - f) College St at a point 344 feet east from its intersection with Magnolia St
 - g) Fitzgerald St at a point 156 feet east from its intersection with S Urbanec St
- B) The operator of a vehicle shall yield the right-of-way to a pedestrian crossing a roadway in a crosswalk.
- C) A pedestrian may not suddenly leave a curb or other place of safety and proceed into a crosswalk in the path of a vehicle so close that it is impossible for the vehicle operator to yield.
- D) The operator of a vehicle approaching from the rear of a vehicle that is stopped at a crosswalk to permit a pedestrian to cross a roadway may not pass the stopped vehicle

Section 7. School zones designated

Within the city:

a) No person shall operate a vehicle at a speed greater than 20 miles per hour when passing through any properly marked neighborhood school zone on a city street. The school zone speed limit shall be effective between the hours of 7:00 a.m. and 4:00 p.m. during school days.

Section 8. 1. Neighborhood speed limits designated

Within the city:

a) No person shall operate a vehicle at a speed greater than 30 miles per hour on any neighborhood city street.

Section 9. Neighborhood speed limits designated - specific streets

Within the city:

- a) No person shall operate a vehicle at a speed greater than 35 miles per hour on Wallace St, from its intersection with Sierra St to its intersection with N Dill St.
- b) No person shall operate a vehicle at a speed greater than 15 miles per hour on Koym St from its intersection with Siesta St to its intersection with W Bernard Dr.
- c) No person shall operate a vehicle at a speed greater than 15 miles per hour on W Bernard St from its intersection with Koym St to a point 434 feet north of its intersection with Koym St.

Section 10. No parking zones designated - all times

The following "No Parking" zones are established within the city.

- a) An area designated with properly marked signs on Fitzgerald St at its intersection with S Urbanec St, on the south side of the street.
- b) Leveridge St from its intersection with Seydler St to its intersection with Clubside Dr, on the west side of the street.

- c) Koym St from its intersection with Siesta St to its intersection with W Bernard Dr, both sides of the street.
- d) W Bernard St from its intersection with Koym St, to a point 489 feet north of its intersection with Koym St., both sides of the street.

Section 11. Penalty. Any person who shall violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$200.

Section 12. Severability. In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the Board of Alderman of the City of East Bernard, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

Section 13. Conflicting Ordinances. All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.
