- 2.COPY OF VALID INSURANCE (YOU MUST HAVE INSURANCE TO REQUEST DSC)
- 3.COPY OF CITATION
- 4.CASHIER'S CHECK OR MONEY ORDER FOR \$144.00: MADE PAYABLE TO EAST BERNARD MUNICIPAL COURT 5.SELF-ADDRESSED STAMPED FNVFLOPF

PLEASE MAKE SURE THE REQUEST HAS A CURRENT MAILING ADDRESS AND TELEPHONE NUMBER. PLEASE NOTE A DEFFERRAL FEE OF \$ 25.00 WILL BE ADDED TO THE AMOUNT OWED. YOU WILL HAVE 14 DAYS TO PAY AFTER DEFERRED DISPOSITION IS GRANTED.
